The review was performed by representatives of the Small Business Administration on May 3, 2011. The on-site review is meant to determine the level of competency of staff personnel, quality of business consulting advice and training. client satisfaction, budget and financial controls and actual performance against key performance goals. Veterans Assistance Center -University Park Facility

On January 31, 2011 the Lone Star College System SBDC officially opened an additional office at the Veterans Affairs Center at the new University Park location (SH 249 @ Louetta). While the SBDC has senior business consultants at each campus in the Lone Star College System, it was felt that having an office at UP would be an added convenience for veterans who came there for assistance with certifications, financial aid and other veteran-related services.

"The idea to set-up the office was a natural since the Center services the needs of veterans throughout the Lone Star College System area, " said Don Ball, Senior Business Consultant with the SBDC. " I am a veteran and I know how important it is to provide the resources for our returning military. Since our services are funded under a grant from the SBA it seemed appropriate to also provide our services at the Center that was established for veterans."

The SBDC offers free small business consulting services, access to customized research and many

other specialized small business services. We assist both start-up entrepreneurs and existing business owners with business plan development, introductions to local area lenders and consulting regarding finance, HR and other aspects of running a business.
